- On-time deadline to submit FAFSA / Dream Act Application for 2017-2018 (2nd)
- Deadline to submit Continuing Student Scholarship Application (2nd)
- Cal Grant GPA Verification deadline for new students (2nd)
- Deadline to pay spring quarter fees (15th)

## APRIL

- Deadline to submit Request for Summer Financial Aid (1st)
- Deadline to meet Financial Aid requirements listed in R'Web (14th)

## MAY

- Submit required Financial Aid documents for Summer Aid (1st)
- Parents may begin applying for the PLUS loan through [studentloans.gov](http://studentloans.gov) (1st)

## JUNE

- Deadline for undergraduate students to complete all required steps to clear Summer Aid on hold in order to not be lapsed for summer session (15th)
- Summer session disbursements begin for Sessions A, C1, D and F (26th)



## AUGUST

- Complete Entrance Counseling and Master Promissory Notes for Federal Stafford Loans and PLUS Loans (15th)
- Fall quarter billing statement runs (16th)

## SEPTEMBER

- Deadline to complete all steps to clear fall Financial Aid on hold (accept awards, complete loan promissory notes and entrance counseling and complete PLUS Loan steps) (1st)
- Deadline to pay fall quarter fees (15th)
- Fall disbursements begin, and refunds disbursed on the first day of classes (15th)

## OCTOBER

- FAFSA / Dream Act available for the 2018-2019 award year (1st)

## DECEMBER

- Deadline to pay winter quarter fees (15th)

## JANUARY

- Continuing Student Scholarship Application available (1st)
